## 1. PURPOSE & SCOPE OF SHOOT

This Agreement grants the Photographer limited rights to use photographs and/or video footage taken of **Jasmine Alysha** on the agreed date(s), strictly under the terms defined below.

## 2. GRANT OF RIGHTS

**Jasmine Alysha** grants the Photographer a **limited, non-exclusive license** to use approved images solely for the following purposes:

- Portfolio use (website, social media, printed portfolio)
  - Submission to magazines or publications with prior consent
  - Display on the photographer's personal website or social media
- ✗ No resale, licensing, or third-party use is permitted without written approval from Jasmine Alysha.
- ✗ No use is allowed on adult-content platforms, paywalls, or NFT distribution without explicit, signed consent.

## 3. APPROVAL REQUIREMENTS

- All **nude or implied nude** content must be reviewed and **approved in writing by Jasmine Alysha** before being made public.
- **Jasmine Alysha** reserves the right to **reject or withhold approval** of any image or video at her sole discretion.
- Approved content must be presented in a tasteful, non-exploitative manner that aligns with her public brand and professional standards.

## 4. TAKEDOWN / RIGHT-OF-REFUSAL CLAUSE – NUDE & IMPLIED CONTENT

Due to the sensitive nature of certain imagery, **Jasmine Alysha** retains the following rights:

1. **Right of Refusal**  
No nude or implied nude images may be shared, sold, or published without **explicit, written consent** from Jasmine Alysha.
2. **Right to Request Removal**  
If consent is later revoked, Jasmine Alysha may issue a written takedown request for any image that:
  - Was used outside the agreed-upon terms;
  - Is harmful to her reputation or emotional well-being;
  - Violates previously discussed boundaries or usage limitations.

### 3. Removal Timeline

The Photographer (or any third-party with access) agrees to comply with all takedown requests **within ten (10) business days** of receipt.

### 4. Restricted Use

Unless given written authorization:

- **✗** No uploading to adult websites or adult-themed social media
  - **✗** No use in NFTs or digital asset sales
  - **✗** No monetized distribution (e.g., OnlyFans, subscription platforms)

## 5. COPYRIGHT & IMAGE OWNERSHIP

The Photographer retains **copyright ownership** of the images; however, any **usage** beyond this Agreement (especially for commercial gain) is **strictly prohibited without written permission** from Jasmine Alysha.

## 6. IMAGE DELIVERY & MODEL COURTESY

Photographer agrees to deliver a minimum of **three (3) edited images** as a courtesy to Jasmine Alysha, especially if she provided her own **wardrobe, makeup, or location**.
