Booking Rates:

- \$150 per hour for all styles of modeling excluding implied nude within the boundaries of the 757 area.
- Implied nude rates: \$175 per hour (minimum 2-hour booking), strictly no exposed genitalia shots.
- For bookings outside of the 757 area, the rate is \$175 per hour, inclusive of travel expenses.
- If Jasmine Alysha is already booked or staying in a certain area, all local bookings in that area will be considered at the rate of \$150 per hour.

Booking Terms:

1. **Creative Brief Requirement:** Photographer agrees to submit a detailed written plan and/or mood board at least 7 days prior to the shoot date. Approval of the concept is required by Jasmine Alysha or her management.

2. **Wardrobe Provision:** If Jasmine Alysha provides wardrobe, styling, etc, the photographer agrees to deliver a minimum of three (3) professionally edited images from the photoshoot to Jasmine Alysha within 14 days of the shoot date.
3. **Implied/Nude Photography:** If the shoot involves implied nude photography, the photographer explicitly agrees to disclose all intended platforms and usage of the resulting images prior to the shoot. Written confirmation and consent must be provided by Jasmine Alysha and/or her management.
4. **Image and Content Review:** Jasmine Alysha and her management reserve the right to review and approve all images, video footage, and behind-the-scenes (BTS) content prior to public posting or commercial usage. Photographer agrees to comply with any content modification or removal requests.
5. **Code of Conduct:** Photographer agrees to strictly adhere to the established Code of Conduct, ensuring professionalism and ethical behavior throughout the shoot. This includes respecting Jasmine Alysha's boundaries, maintaining appropriate language and demeanor, and refraining from any unwanted physical contact.
6. **Usage Rights:** Images produced from the shoot may not be resold, distributed, or licensed without explicit written approval from Jasmine Alysha and her management. Commercial usage must be explicitly stated and agreed upon in writing before the shoot.
7. **Travel Expenses:** Travel and lodging expenses for Jasmine Alysha will be clearly outlined and agreed upon prior to booking confirmation. Any additional expenses incurred during the shoot must be pre-approved and reimbursed accordingly.
8. **Booking Approval and Exclusivity:** Due to exclusivity and high demand, not all photographers will be granted access for booking Jasmine Alysha. The decision to accept or deny a booking request is solely at the discretion of Jasmine Alysha and her management.
9. **Cancellation and Rescheduling Policy:** Photographers must provide at least 72 hours' notice for cancellation or rescheduling. Failure to do so will result in the forfeiture of the deposit. Management reserves the right to reschedule due to unforeseen circumstances, with at least 48 hours' notice.
10. **Deposit Requirements:** A 50% deposit is required upon booking confirmation to secure the shoot date and time. The remaining balance is due on the day of the shoot.
11. **Liability Waiver:** Photographer agrees to assume full responsibility and liability for any damages or injuries occurring during the photoshoot, thereby releasing Jasmine Alysha and management from any liability.
12. **Late Arrival Policy:** The booked time starts exactly at the stated start time and concludes at the stated end time. Photographer's delay does not extend the end time or reduce the agreed-upon rate.

I, the undersigned, hereby acknowledge that I have read, understand, and agree to adhere to all terms outlined in this contract. Any violation of these terms may result in legal action, revocation of usage rights, and exclusion from future booking opportunities.
